This Puppy cannot be resold or given away, without permission from the BREEDER (Loyal Siberian Husky ) No refunds of the purchaser price will ever be issued under any circumstances. So, do not enter into this contract thinking a puppy can be 'tried out' and 'returned for a refund!' ( This is not a stuff animal)

A PET PUPPY is defined here to be a Siberian Husky Puppy which is in good health at the time of sale, and embodies the characteristics of the Siberian Husky breed. This PUPPY is purebred and is registerable with the American Kennel Club (AKC). The puppy is sold as a family pet, and is not sold as breeding stock. The BUYER agrees that the puppy will not be bred without express written permission of the Breeder.

The parents of this Puppy are both in good health and available for the BUYER to inspect.

This Puppy is registerd with limited registration, which will not limit participation in any AKC events, but will prohibit breeding and registering offspring.

The BREEDER (Loyal Siberian Husky ) guarantees the above described dog to be healthy at the time of sale. The BREEDER (Loyal Siberian Husky) guarantees the PUPPY to free of deformity or serious health problems . The BREEDER (Loyal Siberian Husky Kennel) guarantees the PUPPY to free of genetic disease for Five years after the puppy's birth.

Hereditary Defects:

If hereditary hip dysplasia, blindness from hereditary eye disease, or any other genetically inherited condition which is life-threatening should develop, the dog will be replaced with one of similar \*quality (pet) at the discretion of the Breeder (Siberian Husky Kennel) as one becomes available if all Buyer responsibilities have been met at the time of diagnosis, The Breeder (Loyal Siberian Husky ) will consider a replacement for other hereditary conditions which are, in the opinion of the Breeder (Loyal Siberian Husky ) found to drastically affect the quality of the dog's life. If a condition develops that can be managed by medications, replacements will be considered on case by case basis only. If a replacement is warranted, the buyer should continue to keep said dog, unless legitimately unable to do so. Note: We will always accept our dogs back: however, returning said dog is not a requirement in order to obtain a replacement, unless otherwise requested by the Breeder (Loyal Siberian Husky ) Buyer will be entitled to a replacement at whatever future point the buyer feels ready to accommodate another dog, provided that one is available at that time. In other words, the replacement can serve as a companion to the existing affected dog, or the buyer can wait until the affected dog passes away before requesting the replacement.

All veterinary expenses related to the treatment of any health problems will be the responsibility of the Buyer. Any related transportation expenses for the replacement- puppy or replacement-dog will be the responsibility of the buyer. The health guarantee is non-transferrable to any new custodian.

This guarantee does not apply to parasites, giardiasis, coccidiosis, or other such minor or ubiquitous conditions. The guarantee does not apply to diseases covered by a regular PUPPY vaccination schedule if the BUYER has not taken the PUPPY to a vet and continued the PUPPY's vaccination schedule.

The BREEDER (Loyal Siberian Husky ) does not assume any liability for injury to said PUPPY after delivery. The BUYER agrees to have this PUPPY examined by a veterinarian within 72 hours of delivery. The BUYER agrees to email or certified mail it to BREEDER (Loyal Siberian Husky ) a copy of veterinarian visit when BUYER takes PUPPY to vet for his or her examination.

The BUYER agrees to maintain the PUPPY's vaccination schedule.

If the PUPPY is found to be other than healthy or any defects is found to instruct BUYER to return it back to the Breeder (Loyal Siberian Husky ), BUYER needs to provide a written statement from BUYER veterinarian no money is refunded but the BUYER has the option of keeping this one or returning it and selecting another PUPPY equal value from the ones on the premises, If no PUPPY is available you will have to wait on the next litter of puppies to arrive.

All appropriate shots for the PUPPY'S age have been given, and a record of this vaccination history is supplied.

The BUYER agrees to maintain the PUPPY'S health in good condition, and to provide yearly examinations by veterinary, vaccinations, parasite prevention, heartworm prevention and internal/external parasite preventative, test, and any other usual procedures necessary to assure good health.

Proper Socialization, Handling or Obedience Classes Are Strongly Recommended

Do not expect the puppy/dog to train him/herself Puppies are temperament tested before leaving, and any concerns will be noted by BREEDER (Loyal Siberian Husky)

Provided with proper socialization. Handling or Obedience classes are Strongly recommended in effort to ensure that the dog will be comfortable and well behaved, especially in new situations. Note: Proof of the attendance of at least 8 weekly obedience classes is required for any puppy/dog exhibiting behaviors beyond the control of the BUYER if any consideration for replacement is to be given ( should the behaviors be deemed by the BREEDER (Loyal Siberian Husky) to be present as a result of a hereditarily based temperament issue.

The BUYER agrees that he/she must take appropriate training measures to establish dominance and ensure that the dog is taught proper manners with respect to "sharing of possessions and food, socialization. The BUYER agrees that he/she will give the dog adequate time and attention, and monitor the dogs disposition and behavior closely.

The BREEDER (Loyal Siberian Husky) has done everything possible to produce healthy sound puppies by raising the puppies in the best way possible in regards to diet, exercise, socialization and veterinary care.
